

Conditions for participating in the "Where is the oldest VEM motor operated?" competition

1. ORGANISER

"Where is the oldest VEM motor operated?" is a competition organised by VEM GmbH, Pirnaer Landstr. 176, 01257 Dresden (hereinafter called VEM).

2. ELIGIBILITY

Participation in the competition is possible only under the conditions of participation listed here. By participating in the competition, the participant accepts these conditions of participation.

Any natural person aged 18 or above and residing in one of the following countries can participate: Norway, Finland, Sweden, Denmark, The Netherlands, Belgium, Austria, France, Switzerland, Spain, Italy, Czech Republic, Slovakia, Poland, UK, Ireland.

Participants must work in the company where the submitted motor is operated. VEM reserves the right to refuse, for good cause, the participation of individual persons from the outset or to exclude them from the competition at a later point in time and also to recall the prize. Good cause exists, for example, in cases of misuse or fraud (including attempted misuse or fraud) or other violations of the conditions of participation. In such cases, VEM reserves the right to revoke prizes retrospectively as well.

3. DESCRIPTION OF THE COMPETITION

We are looking for the oldest motor/generator of the company/brand VEM, which is still functional and in operation.

You can participate in the competition by submitting photos of the motor and the rating plate by email by July 31, 2023. The following data should also be submitted:

- What the motor is used for

A photo may be submitted only once. The submitted photos will be evaluated from August 1, 2023 to august 11, 2023 and the winner will be determined on August 14, 2023. The winner will be notified in calendar week 33. The prize is non-transferable. Commercial resale of the prize is prohibited.

The personal data provided by the participant will be processed exclusively for the purpose of conducting the described competition and is necessary for the implementation and processing of the competition. The date of birth helps us verify if the participant is of age. The legal basis for data



processing is Article 6 Para. 1 b) of the GDPR.

We will delete the personal data once the purpose of storage is fulfilled by the end of the competition and the deletion does not conflict with any legal and, in particular, tax retention obligations.

Data will not be transferred to a third country.

Each participant is entitled to request information at any time on what items of personal data are stored about him or her. In the same way, rectification, restriction of processing, deletion or transfer of data can also be initiated.

Participants have the right to complain to the competent data protection authority about the processing of their personal data. By participating, the participant consents to the storage and processing of the data provided by him/her to the extent described above. The participant may withdraw his/her consent at any time in writing or by sending an email to unternehmenskommunikation@vem-group.com. In this case, the right to participate in the competition will no longer apply.
